**LOCAL, NATIONAL SPONSORS “TEAM UP TO CLEAN UP” WITH 2005 CAPITAL RIVER RELIEF**

***Founding Sponsor Koch Industries Leads Coalition to Clean up Potomac, Anacostia Rivers***

**Washington, D.C.**—National and local businesses are lining up in support of the 2005 Capital River Relief “Team Up To Clean Up” project, which in 2004 was able to remove nearly 50 tons of trash from the Potomac and Anacostia Rivers.

Founding sponsor, Koch Industries, has again taken the lead role in organizing this year’s Capital River Relief, reuniting a coalition of national and D.C.-based environmental groups, sponsors and volunteers for a cleanup of the Potomac and Anacostia Rivers that runs from March 31 through Earth Day, April 22.

“Helping organize Capital River Relief these past two years has shown us the amazing breadth of entities committed to environmental stewardship here,” said Koch Industries’ Mary Beth Jarvis. “Many coalition members work year-round to care for these and other vital waterways, and this project adds to their dedicated efforts. Our fellow sponsors and the local volunteers get involved not only to help remove tons of trash from the rivers but also to raise awareness about the importance of restoring rivers nationwide.”

In addition to donating cash and in-kind materials, many of the sponsor organizations will also have volunteers helping collect, remove and recycle trash from the rivers.

“Capital River Relief is such a powerful project because it illuminates how an individual or small group of people can in fact make a difference in their local community,” said Whole Foods’ Mid Atlantic Region marketing director, Sarah Kenney, about joining the Capital River Relief coalition. Whole Foods sponsorship provides food and refreshments for volunteers throughout the cleanup. The company also helps promote Capital River Relief around the region via in-store marketing efforts.

Capital River Relief 2005 will be anchored by the Alice Ferguson Foundation's April 2 Potomac River Watershed Cleanup and the Anacostia Watershed Society's April 16 Earth Day Cleanup and Celebration. Throughout Capital River Relief, an Illinois-based conservation organization, Living Lands & Waters, will lead the project’s boat- and barge-based cleanup activities.

National Geographic and other sponsors, along with White House and Congressional staff, area universities, and civic groups, will dedicate a full day for employees or students to volunteer. Capital River Relief also provides an opportunity for area businesses to take part in National Volunteer Week (April 17-23) and Earth Day (April 22) activities.
